DIRECTIONS

CARPET

1. Dilution: Dilute by mixing 1 part concentrate protector with 4 parts water.
2. Application: Apply to freshly cleaned carpet using an electric or battery powered sprayer maintaining 35 to 50 psi with an 8004 TeeJet nozzle. Apply evenly over entire carpet surface. Brush or rake the carpet.
3. Coverage: 200 to 400* sq ft per diluted gallon for damp or dry carpet. Coverage depends on carpet pile density; i.e. heavy pile residential requires 1 gal per 200 sq ft , low pile commercial requires 1 gal per 400 sq ft .

UPHOLSTERY

1. Test on an inconspicuous area for any distortion or discoloration.
2. Dilute 1 part Relax to 1 parts warm water. Spray fabric with pump or electric sprayer until lightly damp.
3. Brush fabric to set pile if needed.

INGREDIENT DISCLOSURE

Water, Fluoroacrylate Copolymer, Acetic Acid, Benzisothiazolinone.

INSTRUCCIONES

1. Diluir: Mescle 1 parte del protector concentrado en 1 partes de agua.
2. Aplicacion: Aplique en la alfombra despues de haber sido lavada usando un rociador electrico o de pilas manteniendo

una presion de 35 a 50 psi con una 8004 teejet nozzle. Aplique una capa sobre toda la alfombra . cepille la alfombra cuando este seca.

3. Cobertura: 200 a 400 sq ft por galon diluido para una alfombra humeda o seca.

La cobertura depende del tipo de alfombra. Si es de Buena calidad requiere de 1 galon por 200 sq ft , menos calidad seria 1 galon por 400 sq ft.

TAPICERÍA

1. Pruebe el producto en un área donde no se vea, para asegurarse de que no distorsione o destiña la tela.
2. Diluya una parte de Precedent con una partes de agua tibia. Rocíe el producto en la tela con un rociador eléctrico o tipo bomba hasta que esté un poco húmeda.
3. Cepille la tela si es necesario.

TECHNICAL TIP

Relax is formulated with short chains of fluoro-protector mandated for use by 2015. The transition from long chains to short chains has sometimes resulted in less effective protection. The new short chain is one that has reversed the trend with better water and oil repellency than its predecessor. Every fiber and surface benefits from fluoro-protector treatments. However, for fibers which attract oil like olefin, polyester, triexta (PTT), and most synthetic upholstery, the great oil repellency of Relax helps reduce these fibers affinity for oil. It is smart for the cleaner to select the fluoro-protector product that protects the fibers from their greatest danger. Oil loves to bond to the fibers mentioned above , which results in noticeable re-soiling in those areas as the soil adheres to the oil stuck to the fibers.
