- For BEST results, use product within 60 minutes of mixing.
- Mix four (4) ounces of Chemfree Powder per one gallon of water
- For extreme soil add one (1) ounce of Citrus Solv per one gallon of ready to use Chemfree
- Pre spray area to be cleaned and allow a few minutes dwell time
- For best results, agitate Chemfree into fibers. For carpet, rugs or tile, agitate using the ZrLifter. For upholstery and other textiles, agitate with a horse hair brush

- Extract with empowered water
