## DIRECTIONS:

To be used as the primary cleaning agent or as a rinse agent, in the extraction process for carpets and upholstery.

**For truckmount concentrate:** Add 1.5 to 2 cups Flex ICE to five gallons of cold or warm water. Mix thoroughly until dissolved. For residential carpet, set metering system to run at 2 gallons per hour. For commercial carpet or heavily soiled carpet, set metering system to run at 3 to 4 gallons per hour.

**For portable equipment:** Use 1 ounce Flex ICE per 5 gallons hot water. Mix thoroughly until dissolved. For extra heavy soil use 2 ounces per five gallons of hot water.

## INSTRUCCIONES

Se debe utilizar como agente principal de limpieza o como ayuda de enjuague, en los procesos de limpieza de alfombras por extracción.

**Para su uso en truckmount:** Para preparar el concentrado del tanque de químico para la truckmount, mezclar 1.5 - 2 tazas de Flex ICE con 5 galones de agua tibia hasta que este completamente disuelto. Para las alfombras residenciales ajustar el sistema de inyección del equipo truckmount a 2 galones por hora. Para las alfombras comerciales ajustar el sistema de inyección del equipo a 3 - 4 galones por hora.

**Para los equipos portátiles:** Utilice de 1 onza de Flex ICE por 5 galones de agua caliente (de 1.5 ml por litro—1:640). Mézclelo completamente hasta que se disuelva. Para suelos muy sucios utilice de 2 onzas por 5 galones de agua caliente (de 3.0 ml por litro—1:320).
