Test for colorfastness. Always apply enough to assure direct contact with odor source. In some cases this means complete saturation.

FOR TOPICAL TREATMENT:

- Mix 4-8oz Odor and Urine Treatment per gallon of B-water, depending on severity of odor
- Apply heavily to affected area (approximately 1 gallon per 250sqft)
- Agitate with zrLifter or carpet groomer and allow 5-10 minutes dwell time
- Extract as normal

FOR SUB-EXTRACTION TREATMENT:

- Thoroughly flush affected area with hot B-Water and Flash Xtractor until water runs clear
- Mix 4-8oz Odor and Urine Treatment per gallon of B-water, depending on severity of odor
- Apply heavily to affected area as well as immediate area approximately 6" – 9" beyond visible spot
- Allow 5-10 minutes dwell time
- Extract thoroughly with Flash Xtractor. May choose to flush with hot B-Water if needed
