### DIRECTIONS:

To be used as the primary cleaning agent, or as a rinse agent, in the extraction process for heavily soiled commercial carpets.

**For truck mount concentrate:** Add 1 to 2 cups of Flex FIRE rinse to five gallons of cold or warm water. Mix thoroughly until dissolved. For systems metered on low settings, or for excessively soiled carpets, 3 cups may be used.

**For portable equipment:** Use 1 ounce of Flex FIRE rinse per 5 gallons hot water. For extra heavy soil use 2 ounces per five gallons of hot water.
