

# TM TRUCKMOUNT DESCALER

Step 1

READ LABEL DIRECTIONS AND WARNINGS BEFORE USING THIS PRODUCT.

- Powdered descaler system for removal of hard water deposits from truckmounts.
- Designed with inhibitors to protect metals and surfactant to quickly penetrate hard water scale.
- Readily dissolves in water for safer and easier handling.
- No harsh fumes or excessive foam.
- Designed to be used with Truckmount Descaler Neutralizer to minimize the environmental impact of wastewater. The two-part system ensures a thorough descaling while also neutralizing wastewater that would otherwise remain acidic after descaling.

#### DIRECTIONS:

1. Disconnect truckmount water inlet and solution outlet hoses.
2. Drain enough water from the truckmount water box to allow enough space to empty the entire container of Truckmount Descaler Step 1 into the water box. There must be enough liquid to allow the Step 1 powder to mix and become liquid, and for a gallon of Step 2 to be added last as a neutralizer. An appropriate amount for most truckmounts is a half full water box.
3. Run truckmount to warm water (not hot).
4. Slowly sprinkle 2 pounds (entire bottle) of Truckmount Descaler Step 1 into waterbox to dissolve while truckmount is running.
5. Let truckmount run for 15 to 30 minutes (depending on severity of scale) to release scale from metal parts.
6. Add Truckmount Descaler Neutralizer Step 2 while truckmount is running for 2 minutes to neutralize acid.
7. Flush with clear water for five minutes after starting release of neutralized wastewater.
