This gives the professional cleaner another way to neutralize odors caused by urine contamination. In addition, the natural oxygen will effectively eliminate stains caused by the urine contamination.

DIRECTIONS

This product is safe and effective on all synthetic carpets. Not recommended for wool carpet. Do not use on silk.

1. Always test in an inconspicuous area for colorfastness.
2. Add 4 scoops (8 oz. total) of powder per gallon of water into the hottest water possible (over 160 degrees Fahrenheit) into bucket. Stir product for 30 to 60 seconds. Product should be mixed at the location it will be used. Mix one gallon in 2.5 gallon bucket. The active solution will rise in about two minutes.
3. Consider pulling back contaminated carpet and disposal of cushion. If needed, seal the subfloor with pigmented shellac.
4. Saturate carpet with mixed Pet Force solution.
5. Allow 30 minutes dwell time.
6. Extract solution from carpet preferably using Spot Lifter or Water Claw. Add water directly as needed for better flushing.
7. Check carpet for odor and repeat steps 5-7 if needed.
8. Install new cushion if necessary
9. Always dispose of any unused mixed solution as effectiveness deteriorates rapidly.
10. Apply Groom Solutions TRIPLEPHASE if any stain remains after above procedure.

Sodium Percarbonate (C.A.S.# 15630-89-4), Sodium Carbonate (CAS # 497-19-8), odor neutralizing fragrance.

INSTRUCCIONES

Este producto es seguro y efectivo en alfombras sintéticas. No es recomendable para alfombras de lana. No se use en seda.

1. Haga una prueba preliminar de la copatibilidad del producto en un área poco visible.
2. Anada 4 tazas (8 oz. total) de pluo en un galon de agua caliente (agua caliente 160°) én una cubeta, Agite el producto durante 30 or 60 segundos, el producto debe ser mezclado en el lugar donde se va usar. Mescle un galon in una cubeta de 2-5 galones. La espuma va asubir en 2 minutos.
3. Tomando en cuenta el traste suavizador limpie la alfombra contaminada con éste, y si necejita, sellador en el subpiso use shellac pigmentada.
4. Alfombra saturada mezcle solucion de Pet Force.
5. Dejto por 30 minutos.
6. Extraiga la solucion de la alfombra de preferencia usando un water claw o un spot lifter.
7. Cheque la alfombre sí tiene o lor y repita los pasas del 5-7 sí es necesario.
8. Instale el nuevo protector sí es necesario.
9. Tire la colucion mezclada sí lesobra porque se deteriora rapidamente.
10. Apigle Groom Solutions TRIPLEPHASE ji las manchas per manecen despues de Todo el procedimiento.
