DIRECTIONS FOR USE

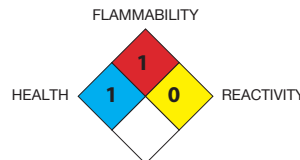
1. Always pretest for colorfastness in an inconspicuous area.
2. Shake well before using.
3. Allow 5-10 minutes of dwell time.
4. Extracted after use. It can be used on all synthetic carpets, including 5th generation nylon and wool fibers.

FOR USE WITH PUMP/ELECTRIC SPRAYERS

For normal soiling, mix 1 part CPS with 32 parts water (4 oz. of solution to 1 gallon of water). For extreme soiling conditions, mix 1 part chemical with 21 parts water (6 oz. of solution to 1 gallon of water.) Spray until carpet is damp. Extract with your normal process. Do not allow carpet to dry before extraction.

MODO DE EMPLEO

1. Siempre haga una prueba en un área discreta.
2. Agite bien el producto antes de usarlo.
3. Permita a la mezcla de la solución que penetre en la alfombra durante 5 a 10 minutos.
4. El producto debe ser extraído después de utilizarse. Se puede utilizar en cualquier alfombra de fibra sintética, incluso en nylon de 5a generación y fibras de lana.

USE CON ROCIADORES DE BOMBA/ELECTRICOS

Para suciedad normal, mezcle 2 onzas de CPS con 5 galones de agua caliente. Para suciedad mayor mezcle de 4 onzas con 5 galones de agua caliente. Aplique el producto hasta que la alfombra esté mojada. Use el proceso normal de extracción. No deje que la alfombra se seque antes de hacer la extracción.
