DIRECTIONS FOR USE

1. Always pretest for colorfastness in an inconspicuous area.
2. For normal soiling mix 1 part chemical with 32 parts water (One bottle makes three ready to use gallons of product). For extreme soiling mix 1 part chemical to 21 parts water (One bottle makes two ready to use gallons of product). Use hot tap water to mix solution (120° F).
3. Spray evenly in an overlapping motion to area being cleaned.
4. Agitate aggressively with preferred agitation machine and allow to dry.
5. Vacuum carpet when dry or at next scheduled vacuum cycle.

INSTRUCCIONES PARA EL USO

2. Para el ensuciamiento normal, mezcle 1 parte químico con 32 partes de agua (Una botella hace tres galones de producto listas para usar). Para el ensuciamiento extremo, mezcle 1 parte químico con 21 partes de agua (Una botella hace dos galones de producto listas para usar). Use agua caliente para mezclar la solución (120° F).
3. Rocíe de manera uniforme en el área que se va a limpiar.
4. Agite agresivamente con máquina de agitación preferida y deje que se seque.
5. aspire la alfombra cuando este seco o en el siguiente ciclo de aspiración.
