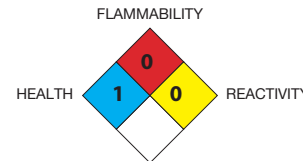

DIRECTIONS FOR USE

Ready to use; do not dilute. Do not apply to color sensitive fibers, leather, satin, silk, suede, velvet, non-colorfast wool, or any fabric that can be damaged by water-based solutions.

1. Always pretest for colorfastness in an inconspicuous area.

FOR USE ON CARPET

1. Apply GSR to stained area.
2. Tamp spot repeatedly with clean spot brush.
3. Blot with clean, white absorbent towel.
4. Repeat if necessary.

FOR USE ON UPHOLSTERY/CLOTHING

1. Apply GSR to clean, white terry cloth towel and gently blot stained area.
2. Blot area with dry portion of towel
3. Repeat process if necessary.
