## DIRECTIONS

To be used as the primary cleaning agent or as a rinse agent, in the extraction process for carpets.

**For truck mount concentrate:** Add 1.5 cups Grungeone to five gallons of cold or warm water. Mix thoroughly until dissolved. For systems metered on low settings or for excessively soiled carpets 3 cups may be used.

**For portable equipment:** Use 1 ounce Grungeone per 5 gallons hot water. Mix thoroughly until dissolved. For extra heavy soil use 2 ounces per five gallons of hot water.

## CONTENTS

Sodium tripolyphosphate (7758-29-4), sodium carbonate (497-19-8), sodium bicarbonate (CAS # 144-55-8), non-ionic surfactant, corrosion inhibitor, lemon fragrance.
