Extraction Cleaning: Portable: Add 1/2 to 1 ounce per gallon of RTU solution. Truckmount: Add 12 ounces to 5 gallon container of concentrated emulsifier.

Other Uses: Add directly to cleaning solutions as needed to control and eliminate odors. 1 to 3 ounces per gallon added to cleaning

solutions, 2 to 8 ounces per gallon for direct spray.

INSTRUCCIONES PARA LAS ALFOMBRAS

Rociado directo: Diluya de 2 a 8 onzas por galón (de 15 a 60 ml por litro—1:64 a 1:16), dependiendo de la severidad del olor. Rocíe el producto uniformemente sobre las áreas afectadas.

Limpieza por extracción: Unidad portátil: Agregue de 1/2 a 1 onza por galón de solución RTU (de 4 a 8 ml por litro—1:256 a 1:128).

Montaje en camión: Agregue 12 onzas por cada recipiente de 5 galones de emulsionador concentrado (18 ml por litro—1:53)

Otros Usos: Agregue el producto directamente a las soluciones de limpieza según sea necesario para controlar o eliminar los olores. Añada de 1 a 3 onzas por galón (de 8 a 24 ml por litro) para las soluciones de limpieza, o de 2 a 8 onzas por galón (de 15 a 60 ml por litro) para el rociado directo.

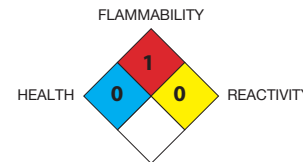
