## STAIN ABSORB FOR STONE

Safely absorbs stains from natural stone surfaces such as marble, granite, limestone, travertine, slate and sandstone. It also works on grout for ceramic & porcelain tile, as well as masonry and concrete.

### DIRECTIONS:

Read entire label before using. Use only as directed. Always test in a small inconspicuous area to determine that the desired results will be achieved. Make sure surface is clean, dry, and free of waxes and coatings. Ensure that area is well-ventilated. Keep children and pets away from the area during application and until surface is dry.

1. Pour the StainAbsorb for Stone onto the stained area.
2. Completely cover the stain up to ¼ " thick. Extend coverage approximately 1 inch around the stain.
3. Allow 24 hours for Stone Absorb to completely dry. Cover with clear plastic wrap to extend dry time when used outdoors, in direct sunlight or other conditions that could cause the Stain Absorb for Stone to dry quickly.
4. Sweep or vacuum away the poultice.
5. For severe and older deposits you may need to repeat the procedure.
6. If discoloration from artificially colored beverages, coffee, tea, mustard, ketchup and other common food and beverage spills remains in the grout, Apply Bridgepoint

StainZONE. Allow time for the StainZONE to penetrate and remove the stain. Test in an inconspicuous place before applying StainZONE to stone.

7. Following spot removal, apply Spinerdy Duraprotect Impregnating Sealer or Solidrock Premium Stone and Grout Sealer.

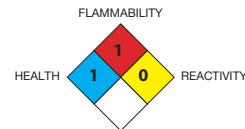
